### ANNUAL REPORT TO THE ARC-PA DEADLINE DECEMBER 15, 2017

All accredited PA programs must complete data entry for the required **annual report** in sufficient time to activate the *SUBMIT* button on the Portal dashboard by **December 15, 2017**. The SUBMIT button will appear on the dashboard November 27, 2017. (Reports for programs first accredited in September 2017 are due March 31, 2018.)

Remember to make sure all of your program information is up-to-date before hitting the “submit” button. Once you hit the submit button your final report data will be submitted as entered and becomes the document of record.

### ARC-PA WORKSHOPS

The ARC-PA **Workshop on Accreditation** will be held on **July 22nd – 24th, 2018**, at the Ritz-Carlton, in Cleveland, Ohio. The workshop will provide PA program faculty an overview of the accreditation process including sessions designed to give participants the opportunity to ask questions and discuss interpretation of individual *Standards*.

The *Accreditation and You* workshop begins at noon Sunday, July 22, 2018 and will adjourn at noon Tuesday, July 24, 2018. An optional *Overview of Accreditation* for new faculty is included in the workshop fee and will be held Sunday morning, July 22, 2018.

Space is limited. Priority will be given to first time registrants from programs scheduled for site visits in 2018-2019. Programs are limited to two attendees per program.

### Entering the ARC-PA Provisional Accreditation Pathway

The ARC-PA will hold a *Provisional Pathway Conference* in Atlanta, Thursday and Friday, January 18-19, 2018 for provisional applicant programs on the 2019 and early 2020 agendas. The conference will be held

again in 2019 for programs on future agendas and for individuals involved in the planning of new PA programs. More information regarding the location, time, and fees for the 2019 conference will be posted on the ARC-PA website as it becomes available.

### **STANDARDS REVIEW AND REVISION**

The ARC-PA has begun the multi-year *Standards* review and revision process. Stakeholder feedback has been sought via email, surveys and open forums at PAEA. The Standards committee is meeting regularly, and has a goal for the first draft of the revised Standards to be ready for stakeholder review in September 2018. Stay tuned for updates over the coming year.

### **INTERPRETING THE STANDARDS**

**Standard E1.09d** requires programs to receive approval from the ARC-PA, using forms and processes developed by the ARC-PA, no less than six months prior to any increase above the approved ***maximum entering class size***.

The approved maximum entering class size is the number of students **newly enrolled** for each admission cycle. Students joining a class cohort who began with different cohort (due to deceleration or leave of absence) may be an addition to the number of students in the approved maximum entering class.

#### **The 'Should' Standards:**

The term '*should*' is used to designate requirements that *must* be met **unless there is a compelling reason**, acceptable to the ARC-PA, for not complying. Programs not meeting any component of a '*should*' standard are **expected to describe in detail why they are unable to do so**. Programs are expected to provide this detail, including attempts to meet the standard, **in the appropriate application narrative**. The commission reviews the application to evaluate the reason(s) a program may provide for not meeting each '*should*' standard.

A program or institution may be cited for failing to comply with a requirement that includes the term '*should*'.

### **CHANGE IN APPEAL FEES**

At its September 2017 meeting, the ARC-PA made an adjustment to appeal fees. The fee for reconsideration following an adverse action by the commission will remain \$5,000. The fee for a formal appeal hearing will increase from \$8,000 to \$12,500. This fee adjustment will be effective January 1, 2018.

### **PANCE REQUIRED REPORTS FOR LOW FIRST TIME TAKER PASS RATES 2018**

The ARC-PA continues to review the PANCE first time pass rate percentages by student cohort. Any program with a PANCE pass rate percentage of 85% or less for the 2017 graduating cohort must submit an analysis of PANCE performance to the ARC-PA **by July 1, 2018**. The NCCPA usually provides programs their previous year's data in February.

### **POST-GRADUATE PROGRAM ACCREDITATION**

Accreditation of post-graduate residency programs was placed in abeyance in 2014. At its September 2017 meeting, the ARC-PA decided to consult with the leaders of the 4-orgs to determine the profession's interest in continuing accreditation of PA post-graduate residency programs. The 4-orgs confirmed that post-graduate residency programs are likely to be needed as the profession progresses. The ARC-PA will begin to accredit PA post-graduate residency programs again, with the goal of having a new, streamlined accreditation process by 2019. Currently accredited post-graduate programs will receive information from the ARC-PA detailing their status following the lifting of the abeyance.

**ARC-PA HAS GONE PAPERLESS**

The ARC-PA has completed revision of its documents, including applications and required reports, to reflect the change to a paperless way of life. You will notice that submission instructions ask programs to submit reports via stick drive, email or by uploading to the portal, depending on the document type. Programs that have an application or report due in the coming months have been **contacted directly with any change in submission instructions.**

Please note that all programs with an accreditation site visit are instructed to have one hardcopy of their application available at the time of the site visit for the visitors' use.

We feel strongly that this move to a paperless world will simplify some of our processes and will be of benefit to programs and the ARC-PA.

Projected Workload

- The current [projected workload](#) includes an additional **62** new PA programs for initial provisional accreditation consideration through September 2021.
- While the need for PA healthcare providers remains strong, the commission remains concerned about the availability of clinical education sites for all types of healthcare students and requests that our collaborating organizations, when possible, promote to their members participation in clinical education. The ability of current and emerging programs to recruit qualified program leadership and faculty also remains worrisome to the commission.
