### March 2016 (following Provisional Monitoring review)

Accreditation-Provisional; Next Comprehensive Evaluation: September 2017 (Final Provisional). The program's maximum class size remains 20 for the third class. The commission noted zero areas of noncompliance with the *Standards*.

### September 2013

Accreditation-Provisional; Next Comprehensive Evaluation: March 2016 (Provisional Monitoring). The program is approved for up to 15 students in the first class of students, 20 in the second class and 20 in the third class.
