- The sponsoring institution's responsibility for complying with ARC-PA accreditation *Standards* and policies.
- The sponsoring institution's support for the program in securing clinical sites and preceptors sufficient in number to allow all students to meet the program's learning outcomes for supervised clinical practice experiences.
- The program director's knowledge of and responsibility for completion of ARC-PA required documents.
- Supervised clinical practice experiences that enable all students to meet program defined learning outcomes for emergent patient encounters.
- Supervised clinical practice experiences that occur in the emergency department and inpatient settings.

A focused probation site visit will need to occur in advance of the March 2025 commission meeting. The program's maximum class size remains 40. The program requested reconsideration of the commission's action. The action was upheld.
